## II. BOARD COMMENTS, SUGGESTIONS AND UPDATES

Handed out new Ordinance 17-08, passed at town Council Meeting on January 16, 2018.

The Board also received per request at December 6, 2017 Hearing a list of information about all present Code Enforcement Liens on property, and the number of Homesteaded properties within the list.

Town Attorney Mr. Schoech discussed and handed out information on Bankruptcy and Code Compliance to assist the Board with the property of Cy Caine, as he has stated he is in bankruptcy several times over the course of all hearings he has been present for.

Town Attorney Mr. Schoech discussed the Florida State Statue 162.09 on foreclosing on a property due to Lien amount. The Board was given typed information on 1915 Antigua in regards to the violations, and the Liens on the property.

The Code Board alone has the right to foreclose on a property per FL STATE STATUE, via vote to approve to close on the property at 1915 Antigua. The Board discussed the matter and decided to invite the property owners only to the next hearing to discuss with them the matters of coming into the purchase of the property, and so therefore postponed their vote to foreclose or not foreclose on 1915 Antigua property, until the Code Board Hearing on February 28, 2018.

Motion by Mr. McCarthy to postpone vote, seconded by Mr. Daughtry; Motion approved (6-0).
