B. **SUMMARY OF APPLICATION 2016-02**

Applicants sought a side variance of 13.5' to construct a canvas carport having a side setback of 1.5' from the property line with relief from the 15.0' setback as required in Section 86-216 (a) (2) of The Town's Code of Ordinance.

Motion made by Mark Roberts to approve the variance with the following conditions, seconded by Pat Conti:

The canvas portion be removed during a hurricane, length on plans is adjusted to 21' and 7' height remains.

Applicant requested a front variance of 5.0' to construct a detached garage having a front setback of 20.0' from the property line with relief from the 25.0' setback and two rear variances of 24.0' and 10.0' having setbacks of 1.0' and 15.0' with relief from the 25.0' setback as required in Section 86-216 (a) (1) of The Town's Code of Ordinance.

B. **SUMMARY OF APPLICATION 2016-03**

Applicants sought a front variance of 5.0' to construct a detached garage having a front setback of 20.0' from the property line with relief from the 25.0' setback and two rear variances of 24.0' and 10.0' having setbacks of 1.0' and 15.0' with relief from the 25.0' setback as required in Section 86-216 (a) (1) of The Town's Code of Ordinance.

The Board discussed the request with Bradley Mehrer. Barry Kramer of 1501 Carandis Circle, Dennis Gallagher of 1511 Carandis Circle and Dolores Harling of 1421 Carandis Circle all spoke in favor of the variance.

D. **BOARD DECISION 2016-03**

Motion made by Mark Roberts to approve the variance with the following conditions, seconded by Terry Glenn:

The structural design look like that of the house in roof and color, that the hedges and fence be put back in place after construction and that the driveway be adjusted to meet the garage.

Motion carried 3-0 to approve the variance.


